Working with your team of Curriculum Leaders you will lead the College's regional operational departments including all of our education sites across the UK.

This role will also work in close partnership with the Commercial team to ensure that the organisation works only with the highest quality sports clubs, performing arts schools and other organisations to drive forward exceptional education programmes.

You will have extensive experience of senior / executive level leadership of Study Programme delivery within FE and Skills. Due to SCL College's unique and innovative delivery model, significant experience of successful multi-site leadership will also be required. You will be innovative, a solution focused thinker and will model partnership working through excellent communication skills and an ethos of teamwork.

- To champion the delivery of excellent teaching and learning especially in the development and use of education technologies.
- In partnership with the Quality team, t o play a lead role in planning, preparation and response to Ofsted inspections.
- To meet organisations and curriculum performance indicators in all areas of responsibility and to set appropriate performance indicators for line managed staff.
- To develop and implement all College strategies for curriculum development across 16-19 Study Programme provision.
- To ensure that SCL College's learner services are comprehensive, inclusive and of excellent quality.
- To manage change in a way that supports staff and learners to achieve.
- To effectively line manage the relevant areas and participate in people management activities across the organisations.
- To establish and develop contacts outside the organisation, attend meetings as a representative of the organisation and build appropriate networks.
